Free Limit Orders

Limit orders must not create an immediate match.	\$O
Symbol must trade on NYSE, AMEX or NASDAQ and be greater than \$1. This applies to all orders that are 200 shares or greater.	

Paid Orders

Paid orders of 200 shares or more	\$0.005 per share
Paid orders with less than 200 shares	\$0.99 flat fee
Market orders or marketable limit orders on all stocks, ETFs and warrants on NYSE, NASDAQ, AMEX	\$0.005 per share Minimum \$0.99
