### Free Limit Orders

<b>Limit orders must not create an immediate match.</b> Symbol must trade on NYSE, AMEX or NASDAQ and be greater than \$1. This applies to all orders that are 200 shares or greater.	<b>\$0</b>

### Paid Orders

Paid orders of 200 shares or more	\$0.005 per share
Paid orders with less than 200 shares	\$0.99 flat fee
Market orders or marketable limit orders on all stocks, ETFs and warrants on NYSE, NASDAQ, AMEX	<b>\$0.005 per share</b> Minimum \$0.99
OTC/Pink Sheets above \$1, between 9:30 AM to 4 PM ET	<b>\$0.005 per share</b> Minimum \$0.99, maximum \$7.95 charge per trade. (\$7.95 per trade up to a maximum of 250K shares).
All equity securities below \$1 from 4 AM to 7 AM ET	<b>\$0.005 per share,</b> <b>with a \$0.99 flat fee/min.</b>
All equity securities below \$1 from 7 AM to 8 PM ET	<b>\$0.005 per share</b> Minimum \$0.99, maximum \$7.95 charge per trade. (\$7.95 per trade up to a maximum of 250K shares).

Options Contract Fee	\$0.59 per contract
<b>Cash Settled Index Options</b> Some commonly traded cash settled options include but not limited to SPX, SPXW, VIX, VIXW.	\$0.65 additional per contract
Option Clearing Corp (OCC) Fee*	\$0.055 per contract
Options Regulatory Fee (ORF)*	Up to \$0.02425 USD per contract, based on prevailing rates

Daily Short Locates	As quoted
Overnight Borrow	Market rate which changes daily based on market conditions.
Overnight Borrow Odd Lots	Odd lot positions (less than 100 shares) will be rounded up to the nearest hundred shares
